VISA SERVICES ON A LIMITED SCALE DURING THE RECOVERY MOVEMENT CONTROL ORDER (RMCO)

Please be informed that during RMCO, visa services on a limited scale will only be available for foreign nationals (of the countries that require visa to enter Malaysia) that are **allowed or have obtained approvals to enter** during RMCO, subject to the availability of visa facilities, as per **Appendix 1**.

Foreign nationals with a valid VDR approval letter and/or entry approval letter (where applicable) who are required to obtain visa prior to entering Malaysia, may email the relevant details and documents, together with a copy of passport to dhaka@imi.gov.my.

Visa facilities for foreign nationals other than the categories as per Appendix 1 remain **temporarily suspended** until further notice. For further enquiries on visa matters, please email or contact the Visa Malaysia One Stop Centre (OSC) at the following:
